Each year, approximately 12,000 men and women are booked into our county jail.

Eventually, most of these offenders will be released back into our communities.

Currently, there are over 600 active parolees and half of them are unemployed in San Luis Obispo County.

Covid-19 has dramatically increased these numbers.

More often than not, men and women will return to us without the relationships to heal and to become accountable for their crimes, and without the connections to find employment and housing to move their lives forward.

RESTORATIVE PARTNERS provides wrap-around services to help bridge the road from prison and homelessness to inclusion back into the community.



Lydia's Story

"I'm proud of myself. I forget how far I've come," Lydia says with a look of relief. "Restorative Partners and Anna's House saved my life. I'm clean, I have my daughter back, I'm working my program and I have a job."

As a ward of the court in San Luis Obispo county, she has only vague memories of a nightmare childhood which consisted of foster homes, psych hospitals, suicide attempts and later, drug addiction. Lydia was homeless at 18. Introduced to drugs by her then abusive boyfriend, the two of them lived in storage units and in the Salinas riverbed. During that time, Lydia became pregnant with her daughter who was removed from her custody. Craving any kind of routine, Lydia clung to her daily trip to Circle K to get a slushy. She continued to spiral down into chaos.

Her life changed when she was given the opportunity to move into one of Restorative Partner's sober living houses. She found out that "reaching out for help" and receiving it, began her road to recovery. She learned the life skills that most people learn from their parents. It took her 2 more years to get clean and get back her daughter.


Lydia now has a five-year plan that will incorporate finishing at Cuesta College, and then getting into the UC Davis Veterinarian School. She says she remains more comfortable with animals than people. She will continue to work part time at local kennels and eventually live on her own.

Last year, we provided 12,118 bed nights, serving a total of 171 individuals: 97 men, 58 women and 16 children




Cost of 1 year of incarceration in a California Prison:

\$33,361






